NON-HISTORIC USE PRODUCTION PERMIT

THIS CERTIFIES THAT:

DAHJUR, L.P. 745 E. Mulberry, Suite 100 San Antonio, Texas 78212

("Permittee"), has applied for a Non-Historic Use Production Permit to withdraw and place to beneficial use groundwater from within the District, and that the Board of Directors of the Culberson County Groundwater Conservation District ("District"), pursuant to the Rules of the District (adopted August 24, 2011, as amended March 7, 2012) ("District Rules"), has APPROVED the application and issues the permit as follows:

1 Permit Category

This permit is a Non-Historic Use Production Permit ("NHUPP").

2 Permit Term

The term of this permit is ten years from the date of issuance.

3 Groundwater Source

The source of groundwater is the Wild Horse Flat Aquifer (the "Aquifer").

4 Annual Groundwater Withdrawal Amounts

4.1 Per calendar year, and subject to the proviso, Permittee is authorized to withdraw groundwater from the Aquifer for beneficial, nonwasteful use for irrigation of an agricultural crop 5.0 acre-feet per acre of land on the property owned by Permittee, as described in Exhibit A, which is attached as part of this permit; provided, however, that the land must be both irrigable and actually irrigated and in no event shall the amount exceed 1,250 acre-feet.

4.2 Any land irrigated under this permit shall be irrigable land that is:

a) classified by the United States Department of Agriculture Farm Services Agency as "cropland," which is land capable of being farmed with normal farming equipment; and

(b) classified by the United States Department of Agriculture Natural Resources Conservation Services as "Additional Farmland of Statewide Importance" according to the procedures of Part 657.5 Identification of Important Farmlands (7 CFR 657).

4.3 Permittee shall submit a sworn report to the District no later than the end of the calendar year of how much land was actually irrigated during that calendar year.

4.4 The amount of groundwater authorized in Section 4.1 is subject to proportional adjustment pursuant to Chapter 5 of the District Rules and to cancellation or reduction pursuant to 5.102(f) of the District Rules.

5 Purpose of Use

Permittee may use Aquifer groundwater only for agricultural purposes.

6 Well Name(s), Location(s), and Maximum Rate of Withdrawal

Groundwater may be withdrawn from the Aquifer only from the well(s) located at each of the locations and with a maximum rate of withdrawal (flow rate), as follows:

7 Measurement of Amount of Groundwater Withdrawn

Permittee may withdraw groundwater only from a well that has an operating flow meter that meets the requirements of Chapter 8 of the District Rules and is listed in Section 6 of this permit.

8 Location of Delivery and Place of Use

Groundwater authorized for production in Section 4.1 must be beneficially used within the District's boundaries.

9 Well Construction, Operation, Maintenance, Closure

The wells identified in this permit shall be installed, equipped, operated, maintained, plugged, capped, and closed in accordance with the District Rules and all other applicable federal, state, and local laws. A copy of a state plugging report shall be submitted to the District within 60 days after capping or plugging any well.

10 Water Conservation

Groundwater produced under this permit must be efficiently withdrawn and used in compliance with the District Rules and the District's management plan, and any water conservation plan submitted by Permittee and approved by the District.

11 Conveyance to Place of Use

Groundwater authorized for production in Section 4.1 must be conveyed to the place of use in a manner that prevents evaporation, channel loss by percolation, and waste.

12 Meters; Alternative Measuring Method

Permittee shall install, operate, and maintain the meter or alternative measuring method on the wells identified in this permit in compliance with the District Rules and the manufacturer's instructions.

13 Reports

Permittee shall timely file all applicable reports with the District on forms prescribed by the District as required by the District Rules, the requirements of this permit, and other applicable law.

14 Fees

Permittee shall timely pay and remain current on the payment of all applicable fees to the District.

15 Interruption, Suspension, or Other Limitations Due to Drought

Permittee shall reduce water supply and consumption during times of drought in accordance with the District Rules and the District's management plan and any drought and water conservation plan submitted by Permittee and approved by the District.

16 Groundwater Management Plan

Permittee shall withdraw and use groundwater only in accordance with the District's approved groundwater management plan.

17 Water Quality

Permittee shall use diligence to protect the quality of groundwater in the District and shall comply with the water quality requirements of the District Rules and take no action that pollutes or contributes to the pollution of groundwater in the District.

18 Transfers and Amendments

Permittee may transfer or amend this permit only in compliance with the District Rules.

19 Permit Review, Renewal or Extension Conditions

Permittee is subject to any review, renewal, or extension conditions stated in the permit or the District Rules. This permit is subject to cancellation in accordance with § 5.217 of the District Rules.

20 Change of Name, Address, or Telephone Number

Permittee shall provide written notice to the District of any change of ownership, name of Permittee, authorized representative, well operator, mailing address, or telephone number within 30 days of such change.

21 Inspections by District

Any authorized officer, employee, agent, or representative of the District shall have the right at all reasonable times to enter upon lands upon which a well may be located within the boundaries of the District, including the wells identified in Section 6 of this permit, for the purpose of inspecting or testing such wells, meters, pumps, and the power units of a well or wells, collecting water samples, and making any other reasonable and necessary inspections and tests that may be required or necessary for the formulation or the enforcement of the permits, rules, or orders of the District. Permittee has a duty to ensure that the well site is accessible to District representatives for inspection and to cooperate fully in any reasonable inspection of the wells and well sites by District representatives.

22 Additional Conditions

23.1 This permit is issued subject to the requirements of: (1) Chapter 8816, Texas Special District Local Laws Code; (2) Chapter 36, Texas Water Code; and (3) the District Rules.

23.2 This permit is subject to the standard permit conditions set forth in § 5.216 of the District Rules.

23 Enforcement

The District retains the right to take any and all enforcement actions within its legal authority to enforce compliance with the terms and conditions of this permit.

24 Continuing Jurisdiction of District

This permit is issued subject to the continuing jurisdiction of and supervision by the District, and may be amended from time to time consistent with applicable law, including if the District learns that any of the information set forth in this permit is incorrect on the date issued.

25 Permit Recordation

Within 30 days of the date of issuance of this permit by the District, the District on behalf of the Permittee will record this permit with the County Clerk of Culberson County and provide a copy of the recorded permit to the Permittee. The cost of such recording shall be assessed against the Permittee.

26 References to Law

Any reference in this permit to a statute, rule, or other law of any kind that exists on the date of issuance of the permit includes all subsequent amendments and additions thereto.

27 Other Matters Denied

All other matters requested in Permittee's application that are not specifically granted by this permit are denied.
